

Interview for Sports Coach of BASKETBALL

A. Eligibility criteria for past champion Athletes:

Order of preference	Team sport
1 st preference	Represented India at recognised international competition under recognised NSF/Association of respective sport
2 nd preference	Part of medal winning team at Senior National past championship conducted by recognised NSF OR Part of medal winning team at Khelo India Games
3 rd preference	Part of medal winning team at National AIU past championship
4 th preference	Represented State in Senior National Past Championships conducted by recognised NSF OR Participation in Khelo India Games


B. Age Limit: Maximum age limit for applicants will be 40 years. However, relaxation may be accorded in deserving cases.

C. Tenure: The contractual engagement will be initially for a period of 02 (two) years which could be further extended on the basis of performance.

D. Remuneration: Fixed monthly remuneration of Rs. 25,000/-, i.e. Rs. 3 lakhs per annum.

E.
